



Harrisburg City Council Minutes January 8, 2019

The Harrisburg City Council met on this date at the Harrisburg Senior Center, located at 354 Smith St., at the hour of 6:30pm. Presiding was Mayor Robert Duncan. Also present were as follows:

Administration of the Oaths of Office for the Mayor and 3 Council Members

The City Recorder administered the Oath of Office to the Mayor, for a term ending December 31, 2020, and the Oath of Office for three Council Members, Adam Keaton, Charlotte Thomas, and Kim Downey, for terms ending Dec 31, 2022. Copies of the signed Oath of Office forms are available in the City Recorders' office.

The matter of Selecting a Council President for a Two-Year Term

- The City Council voted in an open ballot for who would be selected as the City Council President for the next two years. ***Mike Caughey, with 4 votes, as well as one advisory vote, will continue to be the Council President for Calendar Years 2019 and 2020. Kim Downey, Adam Keaton, and Charlotte Thomas all had one vote apiece.*** Ballots with detail of which Councilor voted for whom are available in the City Recorders Office.

The matter of Approving the Consent List

- Downey wanted to obtain additional information in relation to a \$910 purchase that was made with the City Credit Card.

- Latta described the process of how the invoices are approved, and paid, and noted that he and the finance officer had looked at that line as well. The City is somewhat constrained by the software we use, as to what kind of a description we can provide for each item. He will bring the information on the \$910 purchase to the Council at a future meeting. In the meanwhile, they will continue to refine this report, creating a custom report, that will provide the Council with more details. He reviewed what some of the numbers were within the report, and how to read it. He told the Council that the only people holding a credit card are management staff members.

Council members discussed getting more detail on purchases that are more than \$500, but realized that the report is a work in progress. Latta was asked about some of the purchases that were similar amounts paid to the same vendor, and showed how the purchases were split between accounts. He told them that staff will get the information by the end of next week, on any purchases over \$500, so you know what those are. The report is a work in progress, and will continue to be modified as we go forward. He emphasized that anytime you see something in the reports we provide to you, that you are welcome to contact us with your questions.

- Caughey **motioned to approve the Consent List, and was seconded** by Thomas. **The City Council then voted unanimously to approve the Consent List. The Adoption of the Consent List will approved the following:**
 1. **The Payment Approval Report for the month of December 2018**
 2. **The minutes for December 11, 2018**

The matter of a Discussion(s) with Other Agencies: Although this was on the agenda, and the Council was provided with the report (Please see addendum No.1) from the Linn County Sheriff's Office, Latta reminded the Council that due to all the conflicting meetings being held on Tuesday nights, that the deputies would discuss the report at the work session in the second meeting of the month.

The matter of Discussing an Enterprise Zone Extended Abatement

Staff Report: Latta reiterated the information in the agenda bill, noting that a 3-year tax abatement request wouldn't come to the City of Harrisburg for approval; it would automatically be approved by whichever sponsor is processing the application. However, when the time period exceeds that, it requires all sponsors to approve it.

Council wanted to verify that the property tax exemptions wouldn't affect Harrisburg, and Latta was able to explain that it didn't; that tax exemption would be in Lane County, not Linn. This was simply something that had to be approved by all co-sponsors for the Harrisburg Enterprise Zone. He further explained how Enterprise Zones are set up in the State of Oregon.

- Keaton **motioned to approve Resolution No. 1207, "A RESOLUTION APPROVING AN EXTENDED PROPERTY TAX ABATEMENT AGREEMENT BETWEEN THE CITY OF HARRISBURG, A CO-SPONSOR OF THE HARRISBURG ENTERPRISE ZONE, AND NORTHERN GOLD FOODS USA, LLC - GRAIN MILLERS, INC."** He was seconded by Downey, and the City Council voted unanimously to approve Resolution No. 1207, and thereby approving the property tax abatement agreement for Northern Gold Foods USA, LLC-Grain Millers Inc.

The matter of Converting Two One-Foot Wide Reserve Strips (15S04W15DB 6500 and 9000) Into Right-of Way, as part of the Marcus Landing Subdivision, and Approving Resolution No. 1208.

Staff Report: Latta summarized the information in the agenda bill, and answered questions about the partition plat for the property located to the west of Tract C, as shown on page 18 of the agenda. He noted that previously, the other tracts in this subdivision, and those in South and

North Eagle Subdivisions, should have been recorded at the County, but weren't. The City will record all of these with the County.

- Thomas **motioned to approve Resolution No. 1208, "A RESOLUTION GRANTING AND ACCEPTING THE FOLLOWING STREET AND RIGHT-OF-WAY DEDICATION", and was seconded** by Keaton. **The City Council then voted unanimously to approve Resolution No. 1208, which will convert the reserve tracts into public right-of-way.**

The matter of Proclaiming January 20-26 as School Choice Week in the City of Harrisburg, Oregon

- Mayor Robert Duncan first made a statement about how good a school system we have in the City of Harrisburg, and how good our graduate rates are compared to the rest of Oregon. Having choices is important to him, so he chooses to participate in this program every year. He then read the proclamation out loud as it appears in the Council Agenda. ***Mayor Duncan proclaimed the week of January 20 to January 26 as School Choice Week in Harrisburg.***

The matter of Considering a Request by Heidi Miller of Grocery Deals to Lease the City's Right-of-Way.

Staff Report: Latta summarized the information in the agenda bill, and added that these are common in most cities; he dealt with quite a few of them at his last job. The City has no plans for improvements on Territorial St. on the south side of the road for some time, as there is a sidewalk and improved right of way on the north side in this area. He explained the difference between a regular right-of-way permit, which has a fee of \$50, and this request. This will be a legal document, that is revocable at any time. He felt that the fee that Ms. Miller suggested the City charge was fair, based upon the permit fees we already have in place that generally don't apply past a 60 day period. He added that she will be moving her garbage and cardboard bins to the receptacle area planned for in the site plan, but that area doesn't have room for the pallets too. He explained further the requirements of the agreement, and noted that there are some conditions in the agreement, and a further condition that Heidi will need to provide a waiver of remonstrance agreement as well.

- Heidi Miller was with her husband in the audience, and she said that this will provide her with what she needs. She doesn't have room inside for the pallets, and the company who picks them up for her, won't do so unless she has 20 or more.
- Mayor Duncan asked if this action set any kind of a precedent for how much money we accept for this type of an agreement, or the space we are allowing her to lease?
- Latta felt each situation would be unique, and would be handled on a case by case basis.
- Keaton **motioned to direct staff to prepare a revocable license to occupy the Right-of-Way Agreement between the City of Harrisburg and Heidi Miller for Council approval. He was seconded** by both Caughey and Downey. **The City Council then voted unanimously to direct staff to prepare the revocable license.**

The matter of Improvements to the Harrisburg Justice Center

Staff Report: Latta shared the results of the bid that was opened this afternoon. (Please see Addendum No. 2) There were only 4 contractors who bid. He was disappointed in the results. The low bid (\$408,717) had to be rejected, because they didn't submit all the required documentation. The next bid was \$81,205 over the first one, with the highest bid being almost \$175,000 higher than the lowest. He explained the statutes on public contracting, and why we couldn't legally work with the lowest bidder. Staff is recommending that the City Council not accept any of these bids.

Because of the way the projects were bid, we do know that the addition on the building would cost between \$140,000 and \$160,000. Because of that, staff is suggesting that we remove the addition. One of the main reasons we decided to do this project was to create the space we needed for a municipal court, and separate jury room, as well as a slight expansion on the Library. Therefore one of our suggestions is to reconfigure the space inside, and take the space that we told H.A.R.T. they could use. We would still add the kitchen back to the building, because it improves our ability to rent the space. There is re-design work we can do that will lower costs. If so, he would want to go out to bid again in February. Or, Council could decide to scale down everything, and have the Library only expand to the front of the building, and not to the west, and then restore the room that's torn apart. Technically, we have \$225,000 in general fund capital outlay for this project, and an additional \$400,000 or so in community and economic development capital outlay. We've spent \$30,000 to \$40,000 on engineering so far. He would like Council's feedback.

Thomas reminded everyone that part of the costs are dealing with BOLI prevailing wages. Latta said too, that we want to make sure that the public gets the benefit for what we are spending. \$450,000 is more than the public benefit from this remodel. We expected \$300,000 to \$375,000 at the high end; not this kind of figure. Boese was concerned about putting all the money into this building, and wanted to know if the City had it appraised. The City hasn't had it specifically appraised, but does have an insurance value on the structure. Downey expressed that while we want that area to be available for rent, what we expect to get won't cover those types of costs. Council expressed these main points during the following conversation:

- If the City utilizes that front area for a jury room, what is the feasibility of being able to afford placing a bathroom in that location? (Due to its location adjacent to the kitchen, plus location of former janitors closet, and old jail cell waste lines.)
- Should the City look at a construction of a new building, rather than sinking the funds into retrofitting the old one? If so, is there a market for selling the old building?
- Should the City consider a mobile unit, or pre-fab structure for the jury room?
- Should the City consider returning the building to usable form, and then ask the Harrisburg Fire/Rescue Board if we can rent a room for Municipal Court from them in the new station?

Latta suggested that he spend some more engineering dollars to investigate whether a bathroom can be added, reject these bids, and do a new bid based on the change in plans. Then he can see if the changes in the bid are palatable to the City Council. If it's not, then we can consider the cost of putting the building back together. We know we will need a new beam, so the anticipated cost of \$100,000 or more to get it back in shape again. The work in there will make it more structurally sound. Several Councilors liked this idea. Latta added then he can find out the costs on that, do the re-bid, and Council can decide, based on those numbers, whether they want to spend the money on that project, or if they want to pursue the conversation with the Fire/Rescue District. Downey asked him to check into the costs with other cities for modular or other pre-fab structures. Latta said that he would work on getting this out right away, and by the next meeting, he hopes to get the information we need from the engineer. He will give you a progress report at the February business meeting.

- Klemm then **motioned to reject all of the submitted bids as presented by staff. He was seconded** by Downey, and the **City Council voted unanimously to reject all the submitted bids for the Justice Center Remodel Project.**

The matter of Discussing the City's Draft Five-Year Strategic Plan for 2019-2023

Staff Report: Latta reviewed some of the changes he had made to the Strategic Plan in relation to what he presented last year. He took out items that really didn't need to be in the plan, like land use applications. By statute, those have a time frame that he must consider them in, so they don't

need to be in the plan. Objective 8, from last year, directed him to come up with \$100,000 in budget cuts in the current budget year, so that we could have some progress on street repairs. Kesling St. will now be out to bid next week. In FY 2020, we are supposed to increase that to \$175,000. He doesn't see how we can do that, without evaluating the services we provide now. He and Eldridge have been meeting frequently working on exactly that; evaluating our services across the board and how we conduct them. The City is challenged with meeting the projected PERS expenses, which for tier one and two employees, is 30% of payroll, while those in OPSRP (Oregon Public Service Retirement Plan – for employees hired after Aug 29, 2003) are projected at 23% of payroll. That will go up again in 2021. We have some hard decisions we need to make in the future. Those percentages don't include health benefits, which are also increasing. We will look at restructuring our organization a little bit, to still provide the services we have today, but in a different manner than we do now. Our citizens have opened up their wallets enough, between the fire station, school, and water bonds. Even if you look at the money set aside for the remodel project, it's a one-time project. That money, once its gone, is not available in the future. The report we brought to Council says that our ultimate goal is to provide \$250,000 in street maintenance a year. If we don't do that, we aren't doing our jobs. We need a way to provide our basic services, which are utilities and streets.

He summarized some of the other things in the report, and focused on a lot of the successes we've had there recently. That's due to the HRA and Economic Development, and the work the City has done in joining the Main Street Program. (See Addendum No. 3 for the flyer provided to Council) We now have a doctor, and a dentist office, plus the Oddfellows building is in the process of being restored. The Voo will hopefully be able to improve their building with the grant they received. He emphasized some of what we are doing later this year too, with the Smith St, Kesling St., 2nd St, and Macy Street projects. Kesling should be completed before the 4th of July, but unfortunately, Smith St. will likely still be under construction. We'll have to move the 4th of July festivities over to Moore St. for this year. He then reviewed how the changes to process traffic court in Municipal Court will be beneficial to our citizens.

Keaton related how he had a conversation with someone who was concerned that we are taking on the 'Coburg' model for traffic court. However, Latta told him that wasn't true at all. Coburg worked off a fine model; our court works off of fees. He explained how that worked. He is working on educating the deputies on this model. Our Judge is careful to help citizens who are first time offenders, and by imposing fees, he has the ability to modify them. That allows them to pay a percentage, and then if they don't receive any other citations in a certain period of time, we can then write those off. Fines, on the other hand, require DMV notification, and insurance costs go up. He told the City Council that he is prepared to talk about this tonight, but since we have another meeting to go, he recommended tabling this until the next month. Council can come back with ideas for what they want as our priorities. ***Consensus from Council was to not cover this tonight, and to deal with it in the future.***

Others:

- Latta said that he had sent an E-Mail to all the Councilors, about assigning City emails. Did they agree with the information he gave them?
- ***Consensus from Council was yes, to proceed with City assigned E-mails.***
- Eldridge reminded Council that she needed Council Biographies from three more people, plus she reminded them that she had handed out, and emailed, the evaluation forms for our City Administrator.

With no further business to discuss, the City Council meeting adjourned at 8:27, in order to allow the HRA Board to meet.
